SUPPLEMENTARY CONTRACT FOR PERFORMANCE OF REHABILITATION AND BETTERMENT WORK

THIS SUPPLEMENTARY CONTRACT, Made this 12th day of April , 1960, by and among THE UNITED STATES OF AMERICA, hereinafter called the United States, acting through the Regional Director, Region 1, Bureau of Reclamation, hereinafter called the Contracting Officer, and the BIG BEND IRRIGATION DISTRICT, the BOISE-KUNA IRRIGATION DISTRICT, the NAMPA & MERIDIAN IRRIGATION DISTRICT, the NEW YORK IRRIGATION DISTRICT, and the WILDER IRRIGATION DISTRICT, hereinafter called the Districts, and the BOISE PROJECT BOARD OF CONTROL, the operating agency of the Districts, hereinafter called the Board, their successors and assigns.

WITNESSETH, THAT:

2. WHEREAS, the United States, the Districts, and the Board entered into a contract dated November 10, 1959, for performance of certain rehabilitation and betterment work, and the parties desire to modify the provisions of such contract;

NOW, THEREFORE, in consideration of the mutual and dependent stipulations and covenants herein contained, it is mutually agreed by and among the parties hereto, as follows:

- 3. Article 6 of the November 10, 1959 contract is amended by substituting the figure two hundred eight thousand one hundred seven dollars (\$208,107.00) for the figure one hundred seventy-one thousand one hundred seven dollars (\$171,107.00) in the sixth line from the top of page 4 of such contract.
- 4. Except as specifically amended herein, all provisions of the November 10, 1959 contract among the parties hereto shall remain in full force and effect.
